Resolution Number 2018 – 02

A RESOLUTION OF THE LEALMAN SPECIAL FIRE CONTROL DISTRICT OF PINELLAS COUNTY, FLORIDA, ADOPTING THE TENTATIVE LEVY OF AD VALOREM TAXES FOR PINELLAS COUNTY FOR FISCAL YEAR 2018-2019, PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Lealman Special Fire Control District of Pinellas County, Florida, on September 4, 2018, adopted Fiscal Year 2018 – 2019 Tentative Millage Rates following a public hearing as required by Florida Statute 200.065; and

WHEREAS, the Lealman Special Fire Control District of Pinellas County, Florida, held a public hearing as required by Florida Statute 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Pinellas County has been certified by the County Property Appraiser to the Lealman Special Fire Control District as \$1,172,972,152; and

NOW, THEREFORE, BE IT RESOLVED by the Lealman Special Fire Control District of Pinellas, Florida, that:

1. The FY 2018-2019 tentative operating millage rate for Lealman Special Fire Control District is 5.7500 mills which is greater than the rolled-back rate of 5.3040 mills by 8.41%.
2. This resolution shall take effect immediately upon its adoption.
