**A RESOLUTION OF THE LEALMAN SPECIAL FIRE CONTROL DISTRICT OF PINELLAS COUNTY, FLORIDA, ADOPTING THE FINAL LEVY OF AD VALOREM TAXES FOR PINELLAS COUNTY FOR FISCAL YEAR 2018 – 2019, PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Lealman Special Fire Control District of Pinellas County, Florida, on September 17, 2018, adopted Fiscal Year 2018 – 2019 Final Millage Rates following a public hearing as required by Florida Statute 200.065; and

**WHEREAS**, the Lealman Special Fire Control District of Pinellas County, Florida, held a public hearing as required by Florida Statute 200.065; and

**WHEREAS**, the gross taxable value for operating purposes not exempt from taxation within Pinellas County has been certified by the County Property Appraiser to the Lealman Special Fire Control District as \$1,172,972,152; and

**NOW, THEREFORE, BE IT RESOLVED** by the Lealman Special Fire Control District of Pinellas, Florida, that:

1. The FY 2018-2019 operating millage rate for Lealman Special Fire Control District is 5.7500 mills which is greater than the roll-back rate of 5.3040 mills by 8.41%.
2. This resolution shall take effect immediately upon its adoption.
